## SERVING STUDENTS THROUGH PARTNERSHIP

For more than two decades, through our Pinnacle Partnership Program, HIOBS has worked with proven youth development organizations to serve students aged 13-18 who face financial and other systemic barriers to their success. HIOBS provides students with foundational wilderness experiences that catalyze their social and emotional development and solidify their sense of leadership and achievement.

In 2021, Jaden Pinet, a 17-year-old Summer Search Boston student, headed to Maine to take a two-week backpacking course with HIOBS. He was prepared to get outside, do a little hiking, and camp out for a few nights. He wasn't expecting how he would grow as an individual and the resiliency his course would teach him.

"On rainy days, when I smell the wet moss on trees, I think about my trip. It has stuck with me forever and taught me to be confident in myself, take the leap of faith, and trust that I can do anything."

Jaden describes his two instructors as kind and intelligent educators, who are keenly aware of the unique issues facing the BIPOC community. His instructors never questioned their students' realities as members of this community or saw their past experiences as weaknesses. They taught participants to use their individual stories as opportunities to remind themselves of how strong they are. Jaden said, "There is going to be a time in the trip where you will have to take control; you will have to be a leader. I think this is the greatest aspect of the program; it gives everyone the chance to get into the leadership position." Jaden remembers a moment when he was halfway through a hike; he felt like he couldn't go on. His instructor reminded him of how much he had already overcome in his life, which gave Jaden the drive to carry on.

If he could give potential students one piece of advice, Jaden would tell them to have faith in themselves, have confidence, lend support when needed, and know when to ask for help. There are days when you will lead the pack and other days you feel like you can't keep up, but his group found value in always giving each other the time and space to be true to their emotions.

**SUMMER SEARCH BOSTON** provides students with mentoring, impactful summer experiences, and post-secondary advising designed to help them succeed in the futures they choose for themselves. Their 7+ years of wraparound support increases the rate at which their participants graduate high school, access and complete college, and start strong in their careers.

## **CELEBRATING OUR STAFF**

#### **SEA PROGRAM**

**Danny Wiggins** first joined HIOBS in 2018 right out of college from the University of Vermont, where he led expeditions with the school's outing club and worked as an advisor, coordinating trips for the student body, camps, and other outdoor events. While he had previously done some sailing, Danny was interested in developing his skills as both a professional mariner and an outdoor educator, which led him to HIOBS.

Danny has a passion and enthusiasm for all things nautical that started at a young age, and he sees a pulling boat as the perfect platform for teaching. He believes that lessons learned on the water are something students can carry with them throughout their lives. "The conditions are challenging; there's a risk to that," he says, "but seeing the courage students show and the way they carry themselves through says a lot about their character and the impact the course will have on them."

One of Danny's favorite things about his job is seeing that moment on the students' final expedition, where they finally put all the skills they've learned into practice, and "it just clicks; they get it, and they buy in." It's not easy on course, and we ask a lot of our students. He says that seeing them push through those challenges and reach this point is a powerful moment as an instructor.

"I'm grateful for the way the school has supported me and my growth here and how this community has supported each other through the challenges of these past couple of years," says Danny. "It punches a lot of buttons—I've been able to develop professionally and be part of a supportive community."



This admiration and appreciation extend to his fellow staff members as well. Working an Outward Bound course means holding both our staff and students to high standards. Danny says he is consistently impressed by the delicate balance our staff creates between being kind and compassionate and pushing people past what they think they can do.

Whether he's shining up the pulling boats in the boathouse, keeping us focused on safety as a watch officer, or training new staff on technical sailing maneuvers, Danny consistently holds himself and his work to this same high standard. He brings an attention to detail and a level of excellence to everything he does for the HIOBS Sea Program.

#### **LAND PROGRAM**

**Anna Parker**, or AP, is a huge part of the team in Newry. She first joined HIOBS in 2014 while still a student at Middlebury College, working logistics her first summer and returning as an assistant instructor the following year. She has now clocked over 730 days (!), most of those in the field with students. In addition to working as a field instructor and course director, AP is also a trainer and has taught new hires coming into HIOBS for many years. Her team says she is a wealth of knowledge, from cooking in the woods to making every course a place for learning.

HIOBS isn't AP's first exposure to Outward Bound. She was an alumna before she was an instructor. When she was 12, she took a 10-day Thompson Island Outward Bound School course sailing around Boston harbor—and she loved it. That experience stuck with her, so when she was looking for summer jobs, she knew she wanted something outdoor-focused, and Outward Bound was a natural fit.

An incredible advocate for Outward Bound, AP says a handful of things make a HIOBS course special—from the natural beauty of Maine and the diverse wilderness areas our courses cover to the lessons and skills our students learn while out in the field. She says we offer students the chance to push themselves and gain skills they might not learn in a typical classroom, like leadership and compassion toward others. Perhaps most importantly, HIOBS gives people of all ages experiences where they feel ownership over what they do and how they learn.

"Watching students grow is an incredible gift," says AP. "We ask a lot of them, and it requires them to step up. They gain confidence in their physical abilities and their ability to lead others. And it is so cool. It's a really special thing to be a part of."



Two of AP's favorite things about working at HIOBS are the students and the community. As an instructor, she loves seeing students grow and develop while on course. Her team says that AP's approachable, down-to-earth manner helps students feel a sense of belonging and gives them the confidence to do things they may never have done before.

Doing this takes a village, and AP notes that the school has an incredible community of highly dedicated people. And that despite significant challenges in recent years, this community has always worked to ensure that both students and staff have the support they need.


